



**ACCESSORIAL SERVICES AND ADDITIONAL CHARGES  
WHICH MAY APPLY**

<b>Airport Drops/Transfers (MKE):</b>	A fee of \$20.00, or \$ .02 per pound, whichever is greater, will be charged. Maximum Airport Drop/Transfer Fee: \$125.00 Airline drops are applied when freight sits at a terminal waiting for documents
<b>Airport Drops/Transfers (MSP):</b>	A fee of \$20.00, or \$ .02 per pound, whichever is greater, will be charged. Maximum Airport Drop/Transfer Fee: \$125.00 Airline drops are applied when freight sits at a terminal waiting for documents
<b>Airport Drops/Transfers (ORD):</b>	A fee of \$25.00, or \$ .023 per pound, whichever is greater, will be charged. Maximum Airport Drop/Transfer Fee: \$125.00 Airline drops are applied when freight sits at a terminal waiting for documents
<b>Airport Surcharge (ORD):</b>	A fee of \$10.00, or \$2.50 per 100 CWT, whichever is greater, will be charged. Maximum Airport Surcharge: \$125.00 Airport Surcharge is applied to all airport pickups and deliveries to/from the ORD Airport area.
<b>CFS (Container Freight Station) Fee:</b>	A fee of \$12.00 per shipment will be charged for pickups/deliveries to/from various Ocean Warehouses
<b>C.O.D. Fees:</b>	A fee of \$16.50, or \$1.65 per \$100.00 of C.O.D., whichever is greater, will be charged on C.O.D. shipments. Maximum C.O.D. Fee: \$65.00
<b>Consolidation Billing Fee:</b>	A fee of \$15.00 per pro will be charged for consolidated billing.
<b>Convention Centers Pickups or Deliveries:</b>	In addition to the regular rate, a fee of \$75 will be charged. Waiting time will apply after 30 minutes.
<b>Cross-Dock Fee:</b>	A fee of \$12.00, or \$ 3.00 per 100 lbs, whichever is greater, will be charged on loose freight. If freight is palletized a fee of \$12.00 per pallet will be charged.
<b>Devanning Fee:</b>	Please call Customer Care at Aim for a quote.
<b>Dimensional Weight:</b>	Assessed at the rate of one pound per 194 cubic inches. [(L x W x H x pcs.) divided by 194]
<b>Domestic Air Freight Routing Preparation Fee:</b>	\$10.00 per shipment will be charged.
<b>Document Fee:</b>	A fee of \$5.00 per invoice will be charged when supporting documents are required to be mailed with a paper invoice.
<b>Electric Pallet Jack Fee:</b>	A fee of \$50.00 per shipment will apply. This fee will apply to freight that weight more than 1000 lbs and requires the use of a liftgate.
<b>Exam Fee:</b>	LCL = \$30.00 Full Container = \$75.00
<b>Grocery Warehouse Pickups or Deliveries:</b>	In addition to the regular rate, a fee of \$200.00 will be charged if sort & segregate is required.
<b>Hazardous Material Handling Fee:</b>	In addition to the regular rate, a fee of \$25.00 per shipment will be charged for hazardous material shipments.
<b>Import Pickup Attempt Fee:</b>	A fee of \$15.00 will be charged on Import pickups after the first attempt to pick up import freight at airlines or ocean warehouses. Attempts on the weekends will be charged at the first try.
<b>Inside / Non-Dock Pickups or Deliveries:</b>	In addition to the regular rate, a fee of \$25.00, or \$0.06 per pound, whichever is greater, will be charged. Driver restriction maximum is 75 lbs per piece. Additional \$20.00 fee will apply if delivery or pickup includes the use of an elevator or stairs.
<b>Illinois Toll Fee:</b>	\$4.25 per BOL or Shipment will be charged for IL Toll Ways.
<b>IT Handling Fee (Ocean):</b>	A fee of \$25.00 will apply per shipment.

<b>Lift Gate Fee:</b>	For shipments which require a vehicle be equipped with a lift gate, the following rates, (in addition to the regular rate), will be charged for pickups or deliveries to the following points: All Direct Service Points (Straight Truck) \$50.00 All Direct Service Points (Tractor Trailer) Please call Customer Care at Aim for a quote. All Non-Direct Service Points Please call Customer Care at Aim for a quote.
<b>Limited Access Fee:</b>	A Limited Access Fee of \$50.00 will be charged for any service to/from military bases.
<b>Linear Foot Rule:</b>	A shipment that occupies, requires, or utilizes a linear length of 24 feet or more in a trailer (or 12 skid spots) and weighs less than 20,000 lbs, will be considered a trailer loaded to capacity and subject to \$2.75 per mile with a minimum charge of \$530.00. Additionally, a shipment weighing 20,000 lbs or more will also be considered a trailer loaded to capacity and subject to \$2.75 per mile with a minimum charge of \$530.00.
<b>Load or Unload Time:</b>	After 30 minutes, a fee of \$23.50 per 1/4 hour will be charged for loading or unloading time.
<b>On Hand Notification Fee:</b>	Minimum \$15.00 / \$2.00 per 100 lbs / \$175.00 maximum
<b>Opening Up Facility Fee:</b>	\$150.00 minimum will apply to open up an Aim facility during hours when no operations are taking place due to Holiday Observance, weekend closures and other periods before and after the Monday to Friday published operating hours of the facility. Other expedited charges may apply.
<b>Oversize Fee:</b>	Shipments with any shipping unit or piece with a dimension exceeding 8 feet in length up to and including 12 feet in length shall be subject to an additional charge of \$110.00. Shipments with any shipping unit or piece with a dimension exceeding 12 feet in length up to and including 16 feet in length shall be subject to an additional charge of \$250.00. Shipments with any shipping unit or piece with a dimension exceeding 16 feet in length up to and including 20 feet in length shall be subject to an additional charge of \$450.00. Aim reserves the right to not pick up any shipment with any shipping unit with a dimension that exceeds 20 feet in length. If a shipment is tendered containing a shipping unit with a dimension that exceeds 20 feet in length and is inadvertently accepted by Aim, the shipment shall be subject to an additional charge of \$550.00 up to and including 21 feet and an additional \$50.00 per linear foot thereafter. In addition, Aim shall have no liability for loss or damage to shipments tendered and inadvertently accepted by Aim that exceed its extreme length limitation of 20 feet. Fee does not apply on Exclusive Use, Linear Foot, or Truckload Shipments.
<b>Pallet Exchange Fee (PFE):</b>	A fee of \$5.50 will be charged per skid.
<b>Pallet Fee:</b>	A fee of \$7.50 per pallet will be charged.
<b>Pallet &amp; Wrap Fee:</b>	A fee of \$10.00 per skid will be charged for this service.
<b>Pickup Attempt Fee:</b>	A fee of \$25.00 will apply when freight is not available at time of pick up.
<b>Reconsignment Fee:</b>	\$25.00 per shipment will be charged.
<b>Redelivery Fee:</b>	Customers tariff rate from the delivering terminal to the consignee will be charged.
<b>Residential Pickups or Deliveries:</b>	In addition to the regular rate, a fee of \$40.00 will be charged for residential pickups or deliveries. This fee applies for curbside only. Any additional requirements please call for a quote.
<b>Reweight Fee:</b>	\$25 per shipment will be charged.
<b>School/University, Hotel, Mall, Hospital, Farm, Non-Business Pickups or Delivery Fee:</b>	In addition to the regular rate, a fee of \$25.00 will be charged for school or university pickups or deliveries.
<b>Sort &amp; Segregate Fee:</b>	In addition to the regular rate, a fee of \$0.25 will be charged to sort & segregate freight.
<b>Standard Liability &amp; Excess Valuation Fee:</b>	A shipment shall have a declared value of \$0.50 per pound but not less than \$50.00 per shipment. When shipment is declared to have a valuation greater than \$0.50 per pound, a fee of \$0.70 per \$100.00 of valuation in excess of \$0.50 per pound will be charged.
<b>Storage Fee:</b>	After four (4) calendar days, not including the first applicable weekend, a fee of \$5.00 per day per skid spot will be charged. A minimum of 1 skid spot will be charged.

**ACCESSORIAL SERVICES AND ADDITIONAL CHARGES

<b>Terminal Service Fee (Air):</b>	A fee of \$20.00 will apply per shipment.
<b>Time-Specific Fee:</b>	A fee of \$65.00 will apply per shipment, regardless of the party scheduling the appointment.
<b>Trailer Detention:</b>	\$30.00 per day.
<b>Two-Man Pickup or Delivery Fee:</b>	In addition to the regular rate, a fee of \$16.25 per 1/4 hour will be charged. There is a 1 hour minimum fee of \$95.00 to apply per shipment. Additional accessorial fees may apply.
<b>Uncrating/Unpacking/Removal and/or Disposal of Packing Materials:</b>	A fee of \$65.00 per shipment will be charged. After first hour, each additional 1/4 hour, or portion thereof, a fee of \$18.00 will be charged. This fee is in addition to our inside fee. (This service will be provided only when arrangements have been made prior to delivery of the shipment.)
<b>Waiting time:</b>	After 30 minutes, a fee of \$23.50 per 1/4 hour will be charged for waiting time.
